#### Announcement

Due to the intensifying outbreak of the Ebola epidemic, International Service Corps (ISC) and Quest for the Understanding, Solidarity and Transformation (QUEST) have decided to evacuate its volunteers and staff out of Liberia. The organizations are deeply saddened by this decision but feel that this is essential to protect the health and the well being of its employees. At this time, the organizations are unable to predict when they will be able to return to Liberia and continue with their work. However, they have every intention of returning when conditions on the ground allow this.

At the same time, the Health Services International (HIS) will be establishing a presence in Liberia, including in Voinjama, the capital of Lofa County. HIS is a global, humanitarian, nonprofit organization dedicated to saving lives and relieving suffering through health care training and relief and development programs. Its mission is to improve the quality of life through health interventions and related activities that build local capacity in underserved communities worldwide. It provides training and health care to local populations and medical assistance to people in high-risk areas; and works to rehabilitate devastated health care systems and assist in bringing them back to self-reliance.

#### **Questions:**

- For members of ISC and QUEST:
  - What briefing would you provide to HIS to help them understand the local context of Voinjama so that their assistance would be conflict-sensitive?
  - What would you say to your community partners in Voinjama about leaving the projects you have been working on with them?
  - o How do you feel about the evacuation order?
- For members of ILLC and NCHRR:
  - What briefing would you provide to HIS to help them understand the local context of Voinjama so that they would be aware of community needs, interests and expectations?
  - What would you say to the departing international organizations regarding the projects that they are leaving behind?
  - How do you feel about these organizations pulling out of the community at the time of crisis?

#### 2014 Ebola epidemic in Liberia

December 2013	First cases of Ebola in Guinea
March 29	First two cases of Ebola in Liberia
May 25	First confirmed cases of Ebola in Sierra Leone
June 20	599 cases and 338 deaths confirmed in Guinea, Liberia and Sierra Leone
July 27	First reported case of Ebola in Nigeria; Liberia shuts down most of its border crossings
August 8	World Heath Organization (WHO) declares Ebola an "international health emergency"
August 12	Death toll exceeds 1,000
August 27	Doctors Without Borders, an international NGO, calls international response to the Ebola epidemic irresponsible and slow
August 29	First Ebola case reported in Senegal
September 6	4,293 confirmed cases of Ebola in five West African countries; at least 2,296 deaths
September 16	President Barack Obama announces that 3,000 US troops will be sent to West Africa to help build Ebola treatment centers
September 26	WHO puts Ebola deaths at 3,091
September 29	First case of Ebola death in the United States
October 7	Spain has the first case of Ebola contracted outside of West Africa
October 9	Ebola screenings begin at international airports
October 14	WHO says that fatality rate from Ebola is 70%; there are more than 4,447 deaths from Ebola
December 22	There are 19,340 confirmed cases and 7,518 deaths in 8 countries
